

CHAPTER V

CONCLUSION AND SUGGESTION

In this chapter the writer would like to draw some conclusions and provide some suggestion based on the analysis.

5.1 Conclusion

Based on the study conducted by the writer as described in previous chapter, it can be concluded that:

1. The seventh grade students of SMP Negeri 1 Kupang are able to speak English well especially telling about experience with correct pronunciation, grammatical structure, vocabulary and fluency.
2. The level of speaking ability of the seventh grade students of SMP Negeri 1 Kupang is Elementary.
3. The areas of difficulties faced by the seventh grade students of SMP Negeri 1 Kupang in speaking are how to use tenses and how to put words in correct position and how to pronounce the words correctly.

5.2 Suggestion

Based on the result of the study and the conclusion drawn above, some suggestions can be given.

1. To English Teacher

- a. It is advisable to train the students to speak English frequently and everyday motivate the students to read more English books in order to increase their language skills especially speaking skill.
 - b. The English Teacher should encourage the students to speak right and to correct their pronunciation, grammar, vocabulary, and fluency.
2. To the seventh grade students
- a. In order to improve their sub-skills (pronunciation, grammar, vocabulary, and fluency) the students should frequently listen to English news, English songs, and English movies.
 - b. They are also advised to enrich themselves with more vocabularies like reading English books, news papers, magazines, articles and attend English symposiums.
