Based on the data analysis and discussion in this part the writer provides the conclusion of the study and gives some suggestion as well.

5.1 Conclusion

Based on the result of the data analysis the researcher comes with some conclusion to answer the problem of statement in page 3.

1. The eighth grade students of SMP Negeri 8 Kupang in the school year 2014/2015 are able to use elliptical sentences correctly.
2. The ability level of the eighth grade students of SMP Negeri 8 Kupang in the school year 2014/2015 in using elliptical sentences is 8.9 and classified as very good level.
3. The result of the study shows that the students in individual level of ability in using elliptical sentences can be classified as follow:

There are 15 (55.56 %) students' got excellent level of ability, 4 (14.81%) students' got very good level of ability, 2 (7.41%) students' got good level of

ability, 3 (11.11%) students' got fairly good level of ability and 3 (11.11%) students' got average level of ability.

5.2 Suggestion

Base on the conclusion above, the writer would like to give some suggestion as follow:

1. For the English teacher

In order to improve students' ability in using elliptical sentences the writer would like to suggest that the English teacher should give more explanation and practice about elliptical sentences to the students. The practice can be done in school or at home as homework.

2. For the Students

More practice is needed by the students in general and students of SMP Negeri 8 Kupang to improve their ability especially in using elliptical sentences. The practice can be done in classroom or at home by doing the home work. By doing this the students are expected to master the elliptical sentences as one kind of English sentences which might help them when they find this kind of sentence in books or in their daily communication.
